# Braden River High School Key Club Officer Code of Conduct 

## 2022-2023

## *The New Board of Directors reserve the right to alter this Code of Conduct for the 2023-2024 Key Club year.

1. The Officers of the Braden River High School Key Club are expected to maintain a high moral, social, and academic standard. Their job is to lead the club through their positions, but also as community leaders and developers.
2. Officers must be members in good standing while they hold their position.
3. Officers are held to a five-strike rule per quarter. If the strikes are attained, the officer's position will be tried for revocation.
a. Strikes can be attained if an officer:
a. Fails to meet Officer Meeting Attendance requirement as outlined below
b. Fails to meet General Club Meeting Attendance requirement as outlined below.
c. Fails to submit an Officer Report Card on time.
4. Officers must attend $7 / 9$ or around $77 \%$ of the officer meetings per quarter. Otherwise, a strike will be awarded to the absentee officer.
a. The President will be responsible for taking attendance at Officer Meetings.
a. If an officer is consistently late, the officer will meet with the advisors and President.
5. Class Representatives will take attendance at General Assembly Meetings.
6. Officer Report Cards will be submitted once a quarter, as mandated by the President. The goal of these will be to provide constructive feedback for the board overall, as well as individual achievement. In the event of an officer missing a submission of an Officer Report Card, it will be noted of the officer by the President in the attendance record. Based on the Report, the officer may be called to meet with the President and the Advisors.
7. The Vice President of Service will oversee keeping a spreadsheet that documents the dates each Officer was Officer in Charge (OIC) of events.
a. Every officer will be required to OIC at least one event every quarter.
8. All purchases made by Key Club will be fair trade or otherwise as ethically sourced as possible. It is the President and Vice Presidents jobs to see that this is fulfilled under threat of an officer strike.
9. Overall, officers are expected to share the work load evenly and support all events of the club. If an officer is not doing a fair share of the general expectations, the officer will meet with the Advisors and President. General Officer expectations include, but are not limited to:
a. Be OIC of events throughout the year.
b. Attending Spirit Nights.
c. Participate and support committees.
d. Support and attend Office Hours on Wednesday mornings.
10. The Faculty Advisor, Kiwanis Advisor, and Board of Directors will enforce this Code of Conduct.
a. If the officers feel that an officer needs to be removed, a vote may be called by any officer at any meeting and an anonymous ballot may be taken to determine the validity of the claims against the officer in question. If the Board agrees that the officer has not met the requirements listed above, the officer's position in the Board will be revoked.
a. An officer may also make an anonymous accusation to the Faculty Advisor before the meeting. In this case, the Faculty Advisor will call the ballot without disclosing the identity of the accusing party.
b. The Faculty Advisor will tally the ballots and, in the case that a recount is called, the President will review the tally. If the President is the officer in question, the least biased Vice President will fill President's role in this process.
c. The Faculty Advisor and the President will meet with the person in question to try to understand the reason for the infringement. If the Faculty Advisor and President find that the infringement is warranted due to extenuating circumstances, then the charges concerning infringement will be discarded.
